Allotment Committee

County Cllr V Tarbitt gave the following update

- A6071 closed from 2 July at 1900 hours each evening until surfacing work complete.
- Netherby Road footpath cut back on 28 June
- A7 Traffic Speed Warning Device has been in place for 3 weeks - will move ad then return. Comments welcomed.
- The Oaks request for funding for Notice Board now redundant as residents will revert to Oakmere for information dissemination.
- Confirmed will be attending City Council DC&R Meeting on 7 July to speak to the Briar Lea Application (if permission is received) and to listen to the discussion re The Oaks Play Area debate.
- Has accepted invite to Longtown Primary School Forum on the 7 July for a discussion re the River Play Park. No details/background information given so would welcome a Parish update. It was confirmed by the clerk the parish council were unaware of this and no correspondence had been received from the school.
- Carlisle City Council waging a poster war on Dog Fouling and Fly Tipping. Requested posters to display in Longtown and would welcome information on best places for dog fouling ones to be displayed. .

Cllr M Gunson raised the issue of vehicles parking on the kerbs and double yellow line that obstructed drivers' visibility from Albert Street. County Cllr Tarbitt to ask Highways officer to look at this area.

Following response agreed.

This field was the subject of a planning application some 20-25 years ago when there was considerable opposition to the building of approximately 80 houses. The field has always been a natural flood plain and still floods severely several times a year taking water from 2 streams. The Parish Council would not wish to support and future developments on this field.

It is fair to say that, in the case of this planning application, the area in question is probably at the least likely part of the field to be affected by flooding but as with recent climatic changes there can be no guarantee. There are however, several points to mention from the Flood Risk Evaluation. The Beck which runs from Lochinvar Close and on through this field is not the Powdrake Beck which flows into the River ESK FROM Netherby Road. The one in question is the Raeburn Beck. The Flood Protection Scheme mentioned in the application is a type of sump installed at Lochinvar to prevent the flooding of parts of that estate.

Although appearing to have prevented flooding of houses in that part of Longtown, it has made little difference in preventing flooding of the field. Where the proposed development is to take place, as that was not its purpose. The installation of flood retention basins to the east of Longtown does not control the flow sufficiently to make any difference to the flooding of this field; it only protects the Lochinvar Estate.

Full consultation with neighbouring properties taking their views into consideration is essential.
